RELEASE OF CLAIMS

ASSUMPTION OF RESPONSIBILITY

By Player and/or Parent/Guardian in St. Marys Ringette Association

I am or have a player (referred to as We from hereon) in St. Marys Ringette Association organized by the Executive and Directors as recorded in the minutes by the Secretary.

We know that playing Ringette and being involved in its related activities, including practices, travel and preparation involves a significant risk and that myself or my child may suffer personal injury, which could cause pain, suffering, disability or death.

We acknowledge that we are aware that although this is a no-body contact sport, that there is still in fact, some degree of contact involved in the play and that the risk of injury, disability and death is still significant.

In spite of fully knowing these risks, we are signing this release and waiver for the purposes of letting the Executive and Directors know that we are assuming these risks willingly and voluntarily in order to be a player.

By signing this release and waiver, We hereby forever release, discharge and quit claim the Executive and Directors of the St. Marys Ringette Association, or any other organizers in addition to or substitution for them or anybody operating or working in the Association under their direction from all claims for liability that they might otherwise have to us, if we had not signed this release, including the right to sue for compensation for losses arising from personal injury including loss of income, medical expenses, pain and suffering and any other losses or damages for which we might otherwise have been entitled to sue.

This is intended to be and We state that this is a full and final release and waiver of all claims which we might otherwise have had if we had not signed this release.

We acknowledge that we have read over this release.

We have had time to think about it before we signed it, consult with anyone we wanted to and have signed it willingly and are aware of the significance of what we are signing.

I also waive any responsibility by the Association in the case of an accident which may occur on or off the ice or while players are being transported to or from activities. I also authorize the coaches, manager or officials of the Association render whatever first aid is deemed necessary in the case of an accident and to act on my behalf in an emergency. I understand that all players must provide their own equipment including an Approved Face Mask & Helmet and MUST WEAR ALL equipment in GAMES & PRACTICES.
